#### **Business Arising**

#### **AECBC Mandate Committee**

• The President, as Chair of the AECBC Mandate Committee, advised the Board that the Committee at its first meeting the beginning of May will attempt to develop a system mandate for provincial institutions and university college. It is anticipated that a draft will be circulated to the University Colleges for input with responses requested by the end of June and recommendations to the AECBC Joint Council in September or October.

## **Potential Impact of Federal Government Funding Reductions**

• Following the March AECBC Joint Council Meeting a survey of the Institutions will be conducted to ascertain the potential impact. AECBC will also urge the Ministry of Skills, Training and Labour to circulate the Ministry Vision Plan.
