#### 6. Items for discussion

##### 6.1. Pathways Audit

The Chair introduced the topic. The University Registrar provided background of the Pathway model. The committee clarified that the report was not an audit but an analysis of student performance on Pathways. Lori McElroy provided background and context for the discussion. The committee clarified the means to interpret the notes and data. The committee discussed

- steps to take to clarify if the DFW\* rate of Pathway students is as high as it seems from the given data  
\*Proportion of students who received a grade of D or F, or who withdrew from a course.
- the role of Senate and the role of Deans in addressing high DFW percentage,
- finding ways to work with Departments to address DFW rates for all students,
- clarifying reasons for international student success rates,
- additional support currently provided to Pathway students, retention rates of Pathway students,
- matching Pathways courses with a writing or English course,
- connecting a course to the Academic and Career Advancement courses,

*Action items discussed:*

- to include more analysis of failure rates during Program Reviews
- Ask the Teaching and Learning Committee to do more analysis of the student performance on Pathways.
- Share the data with the Faculty Curriculum Committees
- Institutional Analysis and Planning is producing another report on the retention and progression rates of Pathway students
- Defining the qualities or indicators of student success, and include these indicators in *"Guidelines for Pathway Approval"*.
- Forming a task force to answer how to regulate failure or to ensure success.

*Action items to be taken:*

- The Chair will speak with the Faculty of Academic and Career Achievement about the connections between the Pathways courses and the undergraduate courses.
- Add the following item to the *Guidelines for Pathway Approval*,  
*"When a Pathways course is brought forward, consider the percentage of students who receive a D or F, or withdrew from a course (DFW rate)."*
- The Chair will communicate with Faculty Councils to ensure a conversation regarding Pathways courses takes place.

**Elizabeth Worobec moved that the Senate Standing Committee on Curriculum ask the Teaching and Learning Committee to investigate the success of students in light of the data from Institutional Analysis and Planning.**

**Diane Purvey moved that the Senate Standing Committee on Curriculum recommends that Senate amends the Guidelines for Pathway Approval guidelines to include the statement:**

The purpose of this memo is to officially document the June 14, 2018 revisions to the 2018/2019 KPU Academic Calendar Faculty of Health programs. In particular, the Faculty of Health requested the Calendar Editor update the CPR nomenclature to ensure alignment with current industry terminology.

The industry course has recently undergone a name change from CPR Health Care Provider 'Level C' to CPR Health Care Provider (CPR-HCP). Advice received from the Office of the Senate and the Office of the Registrar indicated this was not an academic change and therefore did not require Senate approval.

#### **2017/2018 Academic Calendar:**

**Mandate**

1. Review full program proposals for all programs seeking Senate approval.
2. Review general curricular guidelines or requirements for programs.
3. Review program revisions for all programs seeking Senate approval.
4. Report with recommendations to Senate on the status of full program proposals, program implementations, and program revisions in such a manner and at such times as the program approval/implementation process and Senate may require.
5. Receive and review all new and revised course outlines whose revisions require approval by the Senate and recommend approval to Senate, in accordance with the criteria defined in the Course Outline Manual.
6. Oversee the Course Outline Manual and recommend approval of any non-operational revisions to the Senate.
7. Establish such subcommittees as needed to fulfill the committee's responsibilities.
8. Other duties as assigned by Senate.

**CURRENT, October 10, 2018**

#### **Common Features for all Senate Committees**

- The Chancellor, President and Vice-Chancellor are recognized as voting members of all committees.  
However, it is understood that they are unlikely to be able to attend most meetings and their presence or absence shall not count towards quorum.
- Each Senate committee is comprised of some number of Senators, as appropriate for that committee.
- Each Senate committee is chaired by a Senator
- Chair of a committee should not be the administrator whose portfolio mirrors that of the committee
- Committee membership will be reviewed annually. Members are eligible for reappointment.

**Chair:** Elected by the committee

Normally the chair will be elected in April from among the current membership for a two year term to commence the following September. This information will be included in the report to Senate.

#### **Voting Members**

- Chancellor
- President
- One faculty member from each Faculty
- Deputy Provost
- One student
- Two deans/associate deans (to be selected by the Senate Nominating Committee in conjunction with the Provost and Vice-President, Academic)
- Representative from the Office of the Registrar
- Academic Advisor

---

### **Ex Officio Non-Voting Members**

- One faculty member from each of the Library and Co-operative Education
- Vice-Chair of Senate
- Provost and Vice-President, Academic
- Vice-Provost, Teaching and Learning
- University Registrar or designate

### **Terms of Office**

- Faculty members: three-year term with one-third of these members to be selected each year
- Professional support staff member: three-year term
- Deans and associate deans: reviewed regularly in conjunction with the Provost
- Student or student senator: one-year term
- Senators: three-year term

The chair will inform the committee if a member's absences exceed three meetings. The committee will discuss the situation and the position may be declared vacant by the chair in conjunction with the committee.

The committee has determined that it requires a minimum of three (3) senators as members. This number does not include the deans.
