#### 1. Call to Order

#### 4. Chair's Report

No report.

#### 5. University Librarian's Report

Todd Mundle, University Librarian, provided an update to the committee on the strategic planning initiative and on the budget requests.

A strategic planning committee comprised of approximately 8 members has formed and met once. A second meeting is scheduled for later in November. In their deliberations, the group focused on sustainability, creativity, and quality. While many of the strategies noted in the Academic Plan are a fit with the Library, the strategic planning group intends to focus on 5 or 6 themes, which may

include student success, teaching excellence, research, open education, graduate studies, and Indigenous content.

The group will develop a set of goals and build an assessment process to measure progress towards them. The group is currently gathering information from previous student and employee surveys, as well as results from the Future of the Library initiative from SSCL's May 2019 meeting, and a variety of other stakeholder focus groups. A report on its activities will be made to Senate in February 2020.

The committee discussed plans for library services at the Civic Plaza campus and noted that the large City of Surrey library immediately adjacent to that campus may affect demand for services at that location, that the best learning often takes place in community, and shared physical spaces can foster loyalty to the university.

Todd Mundle shared with the committee that the budget capital requests submitted to Financial Services included 29 projects worth approximately \$1.25M. The amount allocated for the second phase of the Langley campus will need to be increased from what was originally allocated. Both Surrey and Richmond campuses require a large-scale refresh of chairs and technology for 23 study rooms will need updating.

Other requests included additional auxiliary and librarian time to provide current level of service and increase open education projects.

The committee discussed the service review processes at the University and how these link to the strategic plan.

Action: The Chair will bring this question to the full Senate.

#### 6. New Business

#### 6.1. Student Survey Questions

Todd Mundle described the current student survey, asked for feedback and answered questions of the committee. The committee provided a number of helpful small changes to the survey questions.

#### 6.2. Review of Committee Mandate and Membership

Chris Traynor, Chair, informed the committee that all Senate standing committees review their membership and mandate regularly and that KPU is exceptional among the special purpose, teaching universities in that it has a Senate Standing Committee on the Library.

Elise Strand moved that item 1e on the Committee mandate be changed to read: "Reviewing proposed major changes in Library systems and operations."

The motion carried.

#### 7. Items for Discussion

#### 7.1. Alternate Library Fines Payment

Chris Traynor informed the committee that other universities offer the option to donate food items as an alternate means of paying for overdue library fines. The committee discussed whether this might be of interest within KPU.

Action: Todd Mundle to review how charitable donations as an alternate means of payment for overdue fines are managed at other institutions and report to the committee at the next meeting with suggestions about the viability of such an initiative within KPU.

#### Artistic License and Recycling

The Richmond Library provided Fashion Marketing student Smriti Rathore with a load of newspapers that were on their way to recycling for instructor Michael Pope's FMRK 2105 Visual Fashion Merchandising class project. Smitri along with two classmates used the newspapers for a window display at the Still Fabulous Thrift Shop on Main Street. When asked why they wanted to use newspapers for the display, Smitri explained, "We all stand for sustainable fashion and support "pre-loved" products like clothes and bags. For our window display we wanted to reuse waste material instead of buying anything new." The pictures show the creative use of the recycled items.







#### Updated APA Resources Now Available at the Library

APA, the most popular citation style used at KPU, released an updated 7<sup>th</sup> edition in late 2019. The Library's very popular APA Online Guide (58,094 page views in 2019) was updated in December to reflect the new style guidelines. The new guide is a big hit already; from December 10 to January 20, there have been 4,156 page views. For those preferring print resources, the <u>Library's APA quickguide booklets</u> are out at every campus library and the <u>7<sup>th</sup> edition</u> of the APA publication style manual is now catalogued and available to borrow.

#### New Student Welcome at Civic Plaza

On January 7, the Library participated in the Welcome evening organized for new post-baccalaureate and graduate students at the Civic Plaza campus. Business Liaison Librarian **Andre Iwanchuck** gave a brief highlight of Library business resources during lightning rounds of KPU services, and then joined Outreach Librarian **Lisa Hubick** at the Library table. Foot traffic was busy at the table answering many questions students had about their library cards, Papercut and accessing library collections and services remotely.

#### Simplified Library Catalogue Login

Beginning January 23, the Library's catalogue will authenticate employees and students through One.KPU. This means:

- The login people use for the library catalogue will now be the same used to access other KPU sites/applications.
- Because the login information is stored automatically for other KPU applications in One.KPU, once someone
  has accessed a KPU site that requires a login, that person is not prompted to login again during that session
  to request library materials or view their library record.

#### **Reclassifying Canadian Literature Collection**

Library Technical Services cataloguers and Library staff recently completed a reclassification of Canadian Literature held in the library collection. Owing to the discontinuation of a BC local classification scheme for Canadian Literature materials, KPU decided to use the Canadian Literature classification used by Library and Archives Canada. During the months of August through October all Canadian literature materials were pulled from the shelves, reclassified, relabeled and then returned to the shelves. This involved handling over **5,575 items** and shifting materials across ranges of the stacks to place these titles into their new location. Canadian Literature is now found in the classification range of PS8001-8599.

#### Sustainable KSA and the Library Join Forces to Reduce Waste

Students and employees can now drop off their used pens at the Surrey, Langley or Richmond campus Libraries, as well as any KSA offices. In addition to regular ballpoints, we accept mechanical pencils, permanent and dry erase markers and highlighters, along with their caps. The KSA and Library will be recycling all the pens received through the TerraCycle program at Staples.

#### KPU Librarian and Wilson School Faculty Take New York!

Design Liaison Librarian Denise Dale co-presented, with Shirley Thompson (FASN), Iconic Fashion Identities: Education in the Zeitgeist at the Fashion Now and Then Conference hosted by LIM College, New York City, November 1-2, 2019. The presentation was supported by the 0.6% Faculty PD Fund.



#### **KPU Librarian Storms Europe!**

Scholarly Communications Librarian **Karen Meijer-Kline** traveled to Europe in November 2019 to give two presentations on different aspects of our Open Publishing Suite (OPUS). She attended the PKP Scholarly Publishing Conference in Barcelona, presenting with Kate Shuttleworth from SFU Library on "Course journals supporting social justice: developing equitable scholarly communications through in-class publishing projects".

Then in Milan, she presented at the Open Education Global Conference on "The Library as Open Publisher: supporting OER creation on campus". GISday @ KPU

KPU Library and KPU's Department of Geography and the Environment organized a full day of events to mark the fourth annual GIS Day @ KPU on Nov 13, 2019. GIS Day is an annual worldwide celebration for users of Geographic Information Systems (GIS) technology. GIS Day @ KPU brought together KPU GIS users and learners – including faculty, students, and staff – who discussed the many benefits of GIS technology.

GIS Day began with an Introduction to Mapping with Excel workshop, led by KPU Geographer Parthiphan Krishna. Workshop participants gained hands-on experience using the unique mapping features available in Excel.

The day also featured informative presentations:

- David Burns, Vice-Chair of University Senate, explained his use of mapping features in Excel to visualize data from the Surrey School District;
- Lisa Dreves, Stewardship Coordinator Langley Environmental Partners Society, highlighted projects that used QGIS software, including historical wildlife mapping, and streamside habitat conservation;
- Jim O'Leary, Spatial Analyst City of Vancouver, gave an overview of open source GIS, and provided insightful demonstrations of QGIS software in use on various projects including fire station and water fountain site selections in the Greater Vancouver area.

Presentations were followed by a meet-and-greet networking session where KPU faculty, staff, and students with an interest in GIS had the opportunity to share ideas. KPU Library looks forward to hosting additional GIS Day events in the future.

#### 2020 DRAFT Library Strategic Plan

In the fall of 2019 the KPU Library began the process to develop a strategic plan to meet the University's goals outlined in KPU's Vision 2023 and Academic Plan 2023. A library working group was struck to review the key objectives from those two documents and put them in context of how the Library can deliver to support the goals.

The DRAFT strategic plan was constructed with the following considerations:

- Built upon Vision 2023 and Academic Plan 2023
- Check in with Budget and Senate priorities
- Review other BC post-secondary library strategic plans for comparison and starting points
- Maintain enough flexibility to adapt as things change
- Include measurement targets
- Develop space planning for each campus library and library as a whole should be developed in tandem with strategic plan

The working group reviewed the Vision/Academic Plan 2023 objectives narrowing the focus down to 5 areas:

- Student Success
- Teaching Excellence
- Research at KPU
- Indigenous participation at KPU
- Open Education

The working group has identified a number of key actions, implementation examples and measures and they are included in this document. The plan is in draft form and we are seeking input from a variety of stakeholder groups to ensure we are on the correct path. Feedback from stakeholders will be gathered over the two months and we have a target date of March 31, 2020 to have the plan finalized.

### **Indigenous Participation at KPU**

#### **Key Action 1:**

TRC 62 i Make age-appropriate curriculum on residential schools, Treaties, and Aboriginal people's historical and contemporary contributions to Canada a mandatory education requirement for Kindergarten to Grade Twelve students.

TRC 14 iv The preservation, revitalization, and strengthening of Aboriginal languages and cultures are best managed by Aboriginal people and communities

TRC v Funding for Aboriginal language initiatives must reflect the diversity of Aboriginal languages

UNDRIP Article 14.3 States shall, in conjunction with Indigenous peoples, take effective measures, in order for Indigenous individuals, particularly children, including those living outside their communities, to have access, when possible, to an education in their own culture and provided in their own language.

UNDRIP Article 27 States shall establish and implement, in conjunction with Indigenous peoples concerned, a fair, independent, impartial, open and transparent process, giving due recognition to Indigenous peoples' laws, traditions, customs and land tenure systems, to recognize and adjudicate the rights of Indigenous peoples pertaining to their lands, territories and resources, including those which were traditionally owned or otherwise occupied or used. Indigenous peoples shall have the right to participate in this process.

#### **Key Action 2**

UNDRIP Article 31 Indigenous peoples have the right to maintain, control, protect and develop their cultural heritage, traditional knowledge and traditional cultural expressions, as well as the manifestations of the sciences, technologies and cultures, including human and genetic resources, seeds, medicines, knowledge of the properties of fauna and flora, oral traditions, visual and performing arts. They also have the rights to maintain, control, protect and develop their intellectual property over such cultural heritage, traditional knowledge and traditional cultural expressions.

UNDRIP Article 40 Indigenous peoples have the right access to and prompt decision through just and fair procedures for the resolution of conflicts and disputes with States or other parties, as well as to effective remedies for all infringements of their individual and collective rights. Such as decision shall give due consideration to the customs, traditions, rules and legal systems of the Indigenous peoples concerned and international human rights.

TRC 62 ii Provide the necessary funding to post-secondary institutions to educate teachers on how to integrate Indigenous knowledge and teaching methods into classrooms.
